**A RESOLUTION URGING THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) TO INSTALL STREETLIGHTS ALONG AURORA, BOULEVARD, FROM THE INTERSECTION AT EDSA UP TO YALE STREET, CUBAO, QUEZON CITY.**

WHEREAS, the stretch of road from EDSA to Yale Street along Aurora Boulevard, Cubao, Quezon City, which is the site of various business establishments and offices where activities are conducted up to late hours in the evening, has noticeably been dark and gloomy;

WHEREAS, the advent of the Christmas holidays, most particularly, will bring to said location more vehicular as well as pedestrian traffic than usual;

WHEREAS, the safety and security of the employees and clients therein, including the motorists and pedestrians using this busy stretch of road need to be enhanced and assured through the installation of streetlights in the areas.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to urge, as it does hereby urge, the Department of Public Works and Highways (DPWH) to install streetlights along Aurora Boulevard, from the intersection at EDSA up to Yale Street, Cubao, Quezon City.


