RESOLUTION NO. SP-1781, S-2002

A RESOLUTION GRANTING FINANCIAL ASSISTANCE IN THE AMOUNT OF THIRTY THOUSAND PESOS (P30,000.00) TO THE FAMILY OF THE LATE SPO2 VICENTE M. TRANI, MEMBER OF THE CENTRAL POLICE DISTRICT COMMAND (CPDC), PHILIPPINE NATIONAL POLICE (PNP), THE AMOUNT TO BE CHARGED AGAINST THE APPROPRIATIONS FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS IN THE 2002 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS THEREFOR.


NOW, THEREFORE,
