A RESOLUTION AUTHORIZING QUEZON CITY MAYOR, HONORABLE FELICIANO R. BELMONTE, JR., TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE JAPAN JUNIOR CHAMBER, INC., KANTO DISTRICT COUNCIL, FOR THE CONSTRUCTION, OPERATION AND MAINTENANCE OF A DAY CARE CENTER IN BULACAN ST., BARANGAY PAYATAS, QUEZON CITY, AND TO ACCEPT ANY DONATION IN CONNECTION THEREWITH.


WHEREAS, the Quezon City government is in agreement with, and receptive of said proposal.
