RESOLUTION NO. SP-1786, S-2002

A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT (SUP) TO DIGITAL COMMUNICATIONS PHILIPPINES INC., FOR THE CONSTRUCTION/ERECTION OF 6-M HIGH MONOPOLE WITH TOP ELEVATION OF THIRTY-SIX METERS AND SEVENTY CENTIMETERS (36.70M) CELL SITE AT CTK INC. BUILDING, 70 N. ROXAS STREET, CORNER BANAWA STREET, QUEZON CITY.

WHEREAS, petitioner, DIGITAL Communications Philippines, Inc., thru its contractor ALCATEL, has applied with the Quezon City Council for the issuance of a Special Use Permit as required by Ordinance No. SP-22, S-92, otherwise known as the "Quezon City Zoning Ordinance of 1992", and its implementing rules and regulations;

WHEREAS, it is of public interest that the improvement, modernization and expansion of telecommunication facilities, particularly in Quezon City are encouraged.



NOW, THEREFORE,


BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the issuance of a Special Use Permit to petitioner, DIGITAL Communications Philippines, Inc., for the construction/erection of a 6-m high monopole with top elevation of sixty-six meters and seventy centimeters (36.70 m) at CTK Inc. Building, 70 A Roxas St., corner Banawe St., Quezon City; Provided, however, that the petitioner, DIGITAL Communications, Philippines, Inc., shall bear the exclusive responsibility for the sound maintenance of such facilities;

PROVIDED, FURTHER, that the petitioner shall guarantee that no interference with or damage to local appliances or other properties in the area will likely result therefrom.
