RESOLUTION NO. SP-1788, s/2002

A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THE FAMILY OF THE LATE FORMER BARANGAY CHAIRMAN BENITO DUMALAY CLEMENTE OF BARANGAY NAGKAISANG NAYON, WHO DIED LAST JANUARY 18, 2002 DUE TO HEART ATTACK, IN THE AMOUNT OF THIRTY THOUSAND PESOS (Php 30,000.00), TO BE CHARGED AGAINST THE APPROPRIATION FOR GRANTS, SUBSIDIES, FINANCIAL ASSISTANCE AND CONTRIBUTIONS UNDER THE 2002 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS IN THE CITY TREASURY.

Introduced by Councilors MARY ANN L. SUSANO, VOLTAIRE GODOFREDO L. LIBAN III, AIKO MELENDEZ-YLLANA, RAMON P. MEDALLA, ALLAN BUTCH T. FRANCISCO and ERIC Z. MEDINA.

WHEREAS, the late Benito Clemente has served Bgy. Nagkaisang Nayon, Quezon City, as Barangay Captain from 1977 - 1988, and has been the Officer In Charge (OIC) of the Novaliches District Center. He was, thereafter, elected first Kagawad and served this position from 1989-1994 and, prior to his death, he was, elected again and served as Barangay Captain of Nagkaisang Nayon from 1994-1997. His dedicated service to his community deserves merit and recognition.

WHEREAS, to manifest the Quezon City government's gratitude for his invaluable services to Quezon City, there is nothing more appropriate and proper under the circumstances than to extend financial assistance to defray the hospitalization and interment expenses incurred and, likewise, as a means of expressing our sympathy to his bereaved family.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to grant, as it does hereby grant, financial assistance to the family of former Barangay Chairman Benito Dumalay Clemente of Barangay Nagkaisang Nayon, who died last January 18, 2002 due to heart attack, in the amount of Thirty Thousand Pesos (Php 30,000.00), to be charged against the


