


WHEREAS, Section 37 of the Local Government Code has created the local Pre-Qualification Bids and Awards Committee (PBAC) which is primarily responsible for the conduct of prequalification of contracts and suppliers, bidding, evaluation of bids, and the recommendation of awards concerning projects of the city;


WHEREAS, before a contractor/supplier could be prequalified to participate in a bidding of a particular projects, said contractor must belong to the city's roll of contractors and suppliers after being accredited for the purpose;

WHEREAS, a call for accreditation is within the power of the City Mayor in his capacity as Chief Executive and Chairman of the local PBAC;

WHEREAS, in addition to providing a process of transparent public bidding, there is a need to allow new players to participate in the execution and/or prosecution of the different projects of the city so as to allow the flow of diversified expertise and technology into these projects and job opportunities to Quezon City residents.






NOW, THEREFORE,
