RESOLUTION NO. SP-1795, S-2002

A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THE FIVE HUNDRED EIGHTY-SEVEN (587) FAMILIES WHO WERE VICTOMS OF THE FIRE THAT OCCURRED ON FEBRUARY 23, 2002 AT GANA COMPOUND, BARANGAY UNANG SIGAW, QUEZON CITY, COMPRESSIGATION OF ONE HUNDRED SEVENTY-SIX (176) FAMILY HOMEOWNERS AT TWO THOUSAND PESOS (P2,000.00) EACH AND FOUR HUNDRED ELEVEN (411) FAMILY RENTERS/SHARERS AT ONE THOUSAND PESOS (P1,000.00) EACH IN THE TOTAL AMOUNT OF SEVEN HUNDRED SITTY-THREE THOUSAND PESOS (P763,000.00), TO BE TAKEN FROM THE BUDGET OF THE OFFICE OF THE CITY MAYOR UNDER GRANTS, SUBSIDIES AND CONTRIBUTIONS FOR FISCAL YEAR 2002.

WHEREAS, a fire occurred in the morning of February 23, 2002 at Game Compound, Bgy. Unang Sigaw, this city, rendering Five Hundred Eighty-Seven (587) families homeless, as per report of the Social Services Development Department (SSDD), broken down as follows:

Family Homeowners - 176
Family Renter/Sharer - 411

WHEREAS, it is incumbent upon the city government to extend assistance to the above-mentioned fire victims who are constituents of the city to cushion the impact of this unforseen calamity;

WHEREAS, Section 458 (1) (iv) of the Local Government Code of 1992 empowers the Sangguniang Panlungsod to "adopt measures to protect inhabitants of the city from the harmful effects of man-made or natural disasters and calamities and to provide relief services and assistance to victims during and a the aftermath of said disasters or calamities and in their return to productive livel head following said events."

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to grant, as it does hereby grant, financial assistance to the Five Hundred Eighty-Seven (587) families who were victims of the fire that occurred on February 23, 2002 at Gana Compound, Bgy. Unang Sigaw, this city, comprising of One Hundred Seventy-Six (176) Family Homeowners at Two. Thousand Pesos (P2,000.00) each amounting to Three Hundred Filty Two. Thousand Pesos (P352,000.00) and Four Hundred Eleven (411) Family Renters/Sharers at One Thousand Pesos (P1,000.00) each amounting to Four Hundred Eleven Thousand Pesos (P411,000.00) or in the total amount of Seven Hundred Sixty-Three Thousand Pesos (P763,000.00), to be taken from the bedget of the Office of the City Mayor under Grants, Subsidies and Contributions for Fiscal Year 2002.
