RESOLUTION NO. SP- 1798, S-2002

A RESOLUTION URGING THE CITY MAYOR, HONORABLE FELICIANO R. BELMONTE, JR., TO GRANT FINANCIAL ASSISTANCE IN THE AMOUNT OF THIRTY THOUSAND PESOS (P30,000.00) TO THE FAMILY OF THE LATE BARANGAY KAGAWAD JESUS ALONZO OF BARANGAY BUNGAD, QUEZON CITY, TO BE CHARGED AGAINST THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS IN THE 2002 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR.

WHEREAS, Barangay Kagawad Jesus Alonzo died on August 24, 2001, due to stroke or cardiac arrest;


WHEREAS, under Ordinance No. 223, S-91, "PROVIDING FOR BURIAL BENEFITS FOR BARANGAY OFFICIALS AND REGULAR MEMBERS OF BARANGAY TANOD BRIGADES AND APPROPRIATING NECESSARY FUNDS THEREFOR," the heirs of all deceased Barangay officials, including barangay tanods, are entitled to a financial assistance of Thirty Thousand Pesos (P30,000.00);

WHEREAS, at the time of his death, the deceased had served Barangay Bungad as Kagawad for more than ten (10) years;

WHEREAS, the late Barangay Kagawad Alonzo had served Barangay Bungad, this city, faithfully and well and his dedicated services to the community have redounded to the great benefit of the residents thereat and, therefore, deserves the recognition and appreciation of the City as a whole;

WHEREAS, it is only fitting and proper to grant financial assistance to the surviving members of the family of the deceased.








NOW, THEREFORE,


