RESOLUTION NO. SP- 1801, S-2002

A RESOLUTION URGING ALL SANGGUNIANG BARANGAYS QUEZON CITY TO INCLUDE IN THEIR ANNUAL BUDGET APPROPRIATION FOR THE PURCHASE OF SECURITY GADGETS FOR THE USE OF THE BARANGAY TANODS.

WHEREAS, the maintenance of peace and order in the community is one of the most vital functions of our Barangays;

WHEREAS, the desire of the Barangay Tanods in serving as effective peace officers cannot be achieved in the absence of the necessary protective/defensive instruments in combating criminality in the community;

WHEREAS, the equipment suited for the requirement of each Barangay are night sticks with teargas, handcuffs, teargas with holster which, unlike fire rms can be purchased at minimum cost and from local suppliers and more importantly, would not require the acquisition of license for the prospective users;

WHEREAS, in order to qualify for the transaction, proper quotation theet shall be forwarded to the Barangay for appropriate review and inclusion in view of the current budget preparation.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITT IN SESSION ASSEMBLED, to urge, as it does hereby urge, all Sanggutiang Barangays in Quezon City to include in their annual budget the necessary funds for the purchase of security gadgets for the use of their Barangay Tanods.
