RESOLUTION NO. SP-1803, 2002

A RESOLUTION STRONGLY URGING ALL PUNONG BARANGAYS IN QUEZON CITY TO IMMEDIATELY ORGANIZE THE BARANGAY DISASTER COORDINATING COUNCIL IN THEIR RESPECTIVE BARANGAYS AS MANDATED IN EXECUTIVE ORDER NO. 13, DATED AUGUST 12, 1993, OF THE CITY MAYOR, THIS CITY, AND TO REPORT PROMPTLY THEIR COMPLIANCE THEREWITH TO THE CITY MAYOR, THRU THE BARANGAY OPERATIONS CENTER.

Introduced by Councilors BERNADETTE HERRERA-DY, ELIZABETH A. DELARMENTE, ERIC Z. MEDINA, JORGE L. BANAL, JULIAN M.L. COSETENG, DANTE M. DE GUZMAN, JESUS MANUEL "BONG" C. SUNTAY and ALMARIO E. FRANCISCO.

WHEREAS, as early as 1993, the then City Mayor of Quezon City directed the organization of the Barangay Disaster Coordinating Councils at the barangay level in support of the Quezon City Disaster Coordinating Council;

WHEREAS, it has been verified from the Barangay Operations Center, this City, that up to now the mandated formation and organization of said Barangay Disaster Coordinating Councils have not yet been realized in many barangays in the City;

WHEREAS, the non-formation of said Councils might jeopardize and endanger the safety and well-being of city residents in the event that a calamity or disaster suddenly occurs (God forbid) in the City;


WHEREAS, to preclude such an unfortunate and dangerous situation, it will serve the best interest of the City and its residents if said Councils are organized and made operational immediately in all barangays of Quezon City.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to urge, as it does hereby strongly urge, all Punong Barangays in Quezon City to immediately organize their respective Barangay Disaster Coordinating Councils as mandated in the City Mayor's Executive Order No. 13, dated August 12, 1993 and to report promptly their compliance therewith to the City Mayor, thru the Barangay Operations Center.


RESOLVED, FURTHER, that copies of this Resolution be furnished the City Mayor and the Head, Barangay Operations Center.
