RESOLUTION NO. SP-1804, S-2002

A RESOLUTION URGING THE CITY MAYOR, HONORABLE FELICIANOR. BELMONTE, JR., TO GRANT FINANCIAL ASSISTANCE IN THE AMOUNT OF THIRTY THOUSAND PESOS (P30,000.00) TO THE FALLY OF THE LATE PO3 VICTOR V. JOSE, MEMBER OF THE CENTRAL POLICE (ENT). THE AMOUNT TO BE CHARGED AGAINST THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS IN THE 2002 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR.

WHEREAS, PO3 Victor V. Jose had been a policeman for more that eight (8) years and was assigned in the Central Police District Command (CPDC) from October 29, 1999 until his untimely death in the line of duty on December 29, 2001;

WHEREAS, pursuant to Section 3 of Quezon City Ordinance No. SE-154, S-94, members of the Central Police District Command (CPDC) who died in line of duty are entitled to financial assistance by way of additional death or distribute benefit in the amount of Thirty Thousand Pesos (P30,000.00).
