A RESOLUTION URGING THE CITY MAYOR, HONORABLE FELICIANO R. BELMONTE, JR., TO GRANT FINANCIAL ASSISTANCE IN THE AMOUNT OF THIRTY THOUSAND PESOS (P30,000.00) TO THE FAMILY OF THE LATE PO3 VICTOR V. JOSE, MEMBER OF THE CENTRAL POLICE DISTRICT COMMAND (CPDC), PHILIPPINE NATIONAL POLICE (PNP). THE AMOUNT TO BE CHARGED AGAINST THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS IN THE 2002 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR.

WHEREAS, pursuant to Section 3 of Quezon City Ordinance No. SE-154, S-94, members of the Central Police District Command (CPDC) who died in line of duty are entitled to financial assistance by way of additional death or disability benefit in the amount of Thirty Thousand Pesos (P30,000.00).
