## RESOLUTION NO. SP1806s-2002

A RESOLUTION URGING THE CITY MAYOR, HONORABLE FELICIANO R. BELMONTE, JR., TO GRANT FINANCIAL ASSISTANCE IN THE AMOUNT OF THIRTY THOUSAND PESOS (P30,000.00) TO THE FAMILY OF THE LATE SPO1 LORETO L. PARULAN, A FORMER MEMBER OF THE CENTRAL POLICE DISTRICT COMMAND (CPDC), PHILIPPINE NATIONAL POLICE (PNP), THE AMOUNT TO BE CHARGED AGAINST THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS IN THE 2002 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR.

WHEREAS, in recognition of his more than 21 years of long, continuous and unselfish service particularly in the maintenance of peace and order in Quezen City, he deserves to be extended financial assistance to lighten the burden of his bereaved family occasioned by his untimely death.
