RESOLUTION NO. SP 1808-2002

A RESOLUTION AUTHORIZING THE HONORABLE FELICIANO R. BELMONTE, JR., CITY MAYOR OF QUEZON CITY, TO GRANT FINANCIAL ASSISTANCE TO THE BEREAVED FAMILY OF THE LATE EDILBERTO G. DE JESUS, FORMER PUNONG BARANGAY OF BARANGAY BAESA, WHO DIED ON JULY 20, 2001, IN THE AMOUNT OF THIRTY THOUSAND PESOS (P30,000.00), TO BE TAKEN FROM THE APPROPRIATIONS FOR GRANTS, SUBSIDIES, AND CONTRIBUTIONS UNDER THE OFFICE OF THE CITY MAYOR IN THE ANNUAL BUDGET FOR FISCAL YEAR 2002.

WHEREAS, with utmost dedication and loyalty, the late Edilberto G. De Jesus served the people of Barangay Baesa, Quezon City, as the elected Punong Barangay from 1972 to 1982, then as Barangay Kagawad from 1989 to 1993, and later as Acting Punong Barangay from July 12, 1989 to September 12, 1993, a copy of his Service Record is attached as Annex "A" and shall form part of this resolution;

WHEREAS, his untimely demise on July 20, 2001 due to malignant illness caused great emotional as well as financial difficulties to his family as his life savings have gone to the medical and funeral services, a copy of his Death Certificate is attached as Annex "B";

WHEREAS, as a gesture of care and support to the one who once acted as a true public servant, the City Government, through the Honorable Mayor, must extend financial assistance to his bereaved family;


