RESOLUTION NO. SP-1809, S-2002

A RESOLUTION AUTHORIZING HIS HONOR, MAYOR FELICIANO R. BELMONTE, JR., THIS CITY, TO EXECUTE WITH THE NATIONAL INTELLIGENCE COORDINATING AGENCY (NICA), A MEMORANDUM OF AGREEMENT (MOA), GRANTING THE LATTER, FOR A PERIOD OF 25 YEARS, THE USE OF AN OPEN SPACE LOCATED AT LOT 10, BLOCK 17, (LRC) PCS-13293, BARANGAY FAIRVIEW, QUEZON CITY, WITH AN AREA OF 2,000 SQUARE METERS, AS THE SITE OF THE NICA NATIONAL CAPITAL REGION OFFICE.

WHEREAS, Republic Act No. 7227 (Bases Conversion Development Act of 1992) transferred ownership of portions of Camp Bago Bantay to the Bases Conversion Development Authority for immediate disposition;

WHEREAS, included in the aforesaid transfer is the area in Camp Bago Bantay previously occupied by the National Intelligence Coordinating Agency - National Capital Regional Office (NICA-NCRO);

WHEREAS, there is a city-owned parcel of land (open space), particularly described as Lot 10, Block 17, (LRC) PCS-13293, under Certificate of Title No. 180197 containing a total area of Two Thousand (2,000 sq.m.) square meters, registered in the name of the Quezon City government donated by Bonifacio C. Regalado in a Deed of Donation dated July 26, 1978, located at/along Dablis Street, Barangay Fairview, Quezon City;


WHEREAS, there is a need to maximize the use of government lot and property beneficial both to the national and the Quezon City government.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, His Honor, Mayor Feliciano R. Belmonte, Jr., to execute with the National Intelligence Coordinating Agency (NICA) a Memorandum of Agreement (MOA), granting the NICA, for a period of twenty-five (25) years, the use of an open space located at Lot 10, Block 17, (LRC) PCS-13293, Barangay Fairview, Quezon City, with an area of Two Thousand (2,000) square meters, as the site of the NICA-NCR Office.


