RESOLUTION NO. SP-**1814**, S-2002

A RESOLUTION URGING BARANGAY CAPTAINS AND KAGAWADS OF THE DIFFERENT BARANGAYS OF QUEZON CITY TO IDENTIFY BUILDINGS AND STRUCTURES IN THEIR RESPECTIVE JURISDICTION WHICH MAY NOT BE SAFE AND NO LONGER HABITABLE AND THUS CONSIDERED A RISK TO THE SAFETY OF THE PEOPLE LIVING IN THE AREA AND REPORT THE SAME TO THE ENGINEERING DEPARTMENT FOR IMMEDIATE ACTION.

WHEREAS, it has been reported that the Office of the City Engineer and that of the City Building Official cannot cope with the inspection, regular or periodic, of all buildings and structures in Quezon City;

WHEREAS, as a consequence, many buildings and structures in Quezon City cannot be regarded as safe and thus imperil the lives of people and their properties;

WHEREAS, there is a need to augment the inspection personnel of the City Engineer's Office and that of the City Building Official to ensure a wider coverage of such building inspection;

WHEREAS, the Barangay Captains and Kagawads in the different barangay in Quezon City can very well be of help and tapped to identify buildings and structures in their respective areas which may not be safe nor habitable and thus considered a risk to the safety of the people living in the area.


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to urge, as it does hereby urge, all Barangay Captains and Kagawads of the different barangays in Quezon City to identify buildings and structures within their respective jurisdiction which may not be safe and no longer habitable and thus considered a risk to the safety of the people living in the area.


