RESOLUTION NO. SP-**1810** S-2002

A RESOLUTION APPROVING THE RECOMMENDATION OF THE NON-GOVERNMENTAL ORGANIZATION (NGOs) AND PEOPLE'S ORGANIZATIONS (POs) ACCREDITATION COMMITTEE FOR THE ACCREDITATION OF THREE HUNDRED TWENTY-SIX (326) CIVIL SOCIETY ORGANIZATIONS (CSOs), NON-GOVERNMENTAL ORGANIZATIONS (NGOs) AND PEOPLES ORGANIZATIONS (POs), PURSUANT TO THE PROVISIONS OF R.A.7160 AND ITS IMPLEMENTING RULES AND REGULATIONS, IN RELATION TO DILG MEMO CIRCULAR NO. 2001-89.

WHEREAS, the Local Government Code of 1991 and its implementing rules and regulations, require that the City Council shall call all community-based people and non-government organizations, civil society and private sector organizations, including business and professional groups to apply for accreditation with the City Council for possible membership in the local special bodies;

WHEREAS, Ordinance No. SP-23, S-92, an Ordinance creating NGO and PO Accreditation Committee hereinafter referred to as the committee, for brevity, which will process applications for accreditation was enacted to carry out this instruction. The committee is headed by the Chairman of the Committee on Public Affairs, Information and People's Participation, with the Community Relations Officer, the Chairman of the Committee on Barangay Affairs, City Council Secretary and representative from the Office of the Vice Mayor, as members;

WHEREAS, following the instruction contained in DILG Memorandum Circular No. 2001-89, dated July 24, 2001, the City Council, thru His Honor, Vice Mayor Herbert M. Bautista, sent notices of call inviting NGOs, POs and CSOs to apply for accreditation;

WHEREAS, the committee submitted its initial report on August 28, 2001, informing the City Council, among others, that it has sought DILG's approval of its request to extend the deadline in the filing of applications for accreditation for a period of 30 days which was confirmed and approved by the City Council during its regular session on August 28, 2001;

WHEREAS, during the period covering August 27, 2001 to September 28, 2001, a total of 418 applications were processed by the committee using the criteria prescribed in R.A. 7160's implementing guidelines and DILG Memo Circular 2001-89, as follows:

1. Accomplished application for accreditation
2. Board Resolution authorizing the filing of the application for accreditation
3. Certificate of Registration with authorized accrediting agency
4. Objectives and purposes of the organization
5. Annual accomplishment report for the preceding year
6. List of current officers or members of the Board of Directors and financial statement of the preceding year;

WHEREAS, of the total number of applications processed, reviewed and evaluated three hundred twenty-six (326) were found to be qualified for accreditation;

WHEREAS, on the basis of the foregoing premises, the committee submitted its reports and recommended for the approval thereof and the consequent accreditation of civil society organizations, private sector organizations, NGOs and POs therein listed which the City Council in fact approved during its regular sessions on September 4, 2001, September 25, 2001 and November 27, 2001;

WHEREAS, the organizations which have faithfully complied with the requirements for accreditation are mentioned hereunder.

NOW, THEREFORE,


