RESOLUTION NO. SF 1821 S-2002

A RESOLUTION URGING THE CITY MAYOR TO EXTEND FINANCIAL ASSISTANCE TO THE TWO HUNDRED (200) FAMILIES WHO WERE VICTIMS OF THE FIRE THAT OCCURRED ON NOVEMBER 19, 2001 IN METRO HEIGHTS COMPOUND, SANVILLE SUBDIVISION, BARANGAY CULIAT, QUEZON CITY IN THE AMOUNT OF TWO THOUSAND PESOS (P2,000.00) EACH IN THE TOTAL AMOUNT OF FOUR HUNDRED THOUSAND PESOS (P400,000.00) TO BE TAKEN FROM THE BUDGET UNDER GRANTS, SUBSIDIES AND CONTRIBUTIONS FOR FY 2001.

WHEREAS, a fire occurred in the morning of November 19, 2001 at Metro Heights Compound, Sanville Subd., Bgy. Culiati, Quezon City, rendering Two Hundred (200) families homeless, as per report from said barangay;

WHEREAS, it is incumbent upon the city government to extend assistance in any form to the above-mentioned fire victims who are constituents of the city to cushion the impact of this unforeseen calamity;

WHEREAS, Section 458 (1) (iv) of the Local Government Code of 1991 empowers the sangguniang panlungsod to "adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events."



NOW, THEREFORE,




