RESOLUTION NO. SP-1825, s-2002

A RESOLUTION REQUESTING THE HONORABLE CITY MAYOR, FELICIANO R. BELMONTE, JR., AND THE QUEZON CITY HEALTH DEPARTMENT TO ASSIGN A FULL TIME MEDICAL DOCTOR, DENTIST, MIDWIFE, NURSE AND UTILITY AIDE FOR BARANGAY PASONG PUTIK PROPER HEALTH CENTER.

WHEREAS, under Section 17 of R.A. 7160, local government units are empowered to enact ordinance to ensure the efficient and effective delivery of basic services and facilities;

WHEREAS, Barangay Pasong Putik Proper is a newly created Barangay having just achieved its existence last May 12, 1997;

WHEREAS, the building intended for the Health Center in Maligaya Park Subdivision has long been operational;


WHEREAS, their supplies come from Lagro Health Center which are not sufficient because of the influx of patients wherein 80% of the inhabitants belong to the urban poor;

WHEREAS, they want their own separate supply of medicine, facilities and equipment and staff comprising of medical doctor, dentist, nurse, midwife and utility aide because the medical doctor assigned to them is serving in their Barangay only once a week.

BE IT RESOLVED, BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to request, as it does hereby request, the Honorable City Mayor, Feliciano R.
