RESOLUTION NO. SP-18278-2002

A RESOLUTION URGING THE HONORABLE CITY MAYOR TO GIVE FINANCIAL ASSISTANCE TO THE VICTIMS OF THE FIRE THAT OCCURRED IN MATIPUNO STREET (AT THE BACK OF DILG) BARANGAY PINYAHAN, DISTRICT IV, QUEZON CITY, LAST JANUARY 29, 2002, THE AMOUNT TO BE TAKEN FROM THE CALAMITY OR EMERGENCY FUND OF THE CITY GOVERNMENT OR FROM ANY AVAILABLE FUNDS OF THE CITY.

WHEREAS, on the dawn of January 29, 2002, about 3:00 in the morning, a fire occurred and blazed a six (6)-door apartment and adjacent structures in Matipuno St. (at the back of DILG) Barangay Pinyahan, District IV, Quezon City, leaving six (6) or more families homeless;

WHEREAS, the city government can express its sympathy and concern by way of providing financial assistance to the victims of the fire.

NOW, THEREFORE,

BE IT RESOLVED IN THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to urge, as it does hereby urge, the Honorable City Mayor to give financial assistance to the victims of the fire that occurred in Matipuno St., (at the back of DILG), Barangay Pinyahan, District IV, Quezon City, last January 29, 2002, the amount to be taken from the Calamity or Emergency Fund of the City Government or from any available funds of the City, as follows:

house owners - P4,000.00 each house renters - 2,000.00 each house sharers - 1,000.00 each

RESOLVED, FURTHER, that the Social Services Development Department (SSDD) shall validate and authenticate the list of fire victims categorized into family owners and family renters/sharers and to submit the same to the Office of the City Mayor, likewise making representation for the early release of the financial assistance to the qualified recipients.
