A RESOLUTION URGING THE HONORABLE CITY MAYOR FELICIANO R. BELMONTE, JR., TO EXTEND FINANCIAL ASSISTANCE TO NINE (9) FAMILIES AFFECTED BY THE FIRE THAT RAZED A RESIDENTIAL AREA IN DON FRANCISCO ST., VILLA BEATRIZ, BARANGAY MATANDANG BALARA, AT TWO THOUSAND PESOS (P2,000.00) PER FAMILY OWNER AND ONE THOUSAND PESOS (P1,000.00) PER FAMILY RENTER/SHARER WHICH SHALL BE TAKEN FROM THE CALAMITY OR EMERGENCY FUND OF THE CITY GOVERNMENT OR FROM ANY OTHER AVAILABLE FUND IN THE CITY TREASURY

WHEREAS, local government units are empowered under Section 485 (a) (1) (iv), of RA 7160 "to adopt measures to protect the inhabitants of the City from the harmful effects of the man-made or natural calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities, and their return to productive livelihood following said events;"

WHEREAS, a fire razed houses at the residential area in Barangay Matandang Balara on December 31, 2001;

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to urge, as it does hereby urge, the Honorable Feliciano R. Belmonte, Jr., City Mayor, to extend financial assistance to the nine (9) family-victims of the fire that razed a residential area in Don Francisco St., Villa Beatriz, in Barangay Old Balara, at Two Thousand Pesos (P2,000.00) per family owner and One Thousand Pesos (P1,000.00) for each family renter/sharer, the fund to be taken from the Calamity or Emergency Fund of the City Government or from any other available fund in the City Treasury.




