RESOLUTION NO. SP-1832 S-2002

A RESOLUTION AUTHORIZING THE TRANSFER, WITHOUT COST, OF TWENTY-THREE (23) UNITS OF TOYOTA TAMARAW FX REVO OWNED BY THE QUEZON CITY GOVERNMENT TO THE CENTRAL POLICE DISTRICT COMMAND (CPDC)-QUEZON CITY AND TO TURN OVER ALL DOCUMENTS PERTAINING THERETO.

WHEREAS, the General Services Office (GSO) has recommended the transfer, without cost, of the twenty-three (23) units of Toyota Tamaraw FX Revo owned by the City Government for the use of the Central Police District Command (CPDC)- Quezon City;

WHEREAS, the Honorable City Mayor Feliciano R. Belmonte, Jr. has approved the recommendation given by the GSO for the transfer, without cost, from the Quezon City Government to the CPDC of the mentioned vehicles;

WHEREAS, the transfer, without cost, of the twenty-three units Toyota Tamaraw Fx Revo from the Quezon city government to the CPDC-QC will save the former from the insurance and registration costs of the vehicles, thereby aiding the City in augmenting its resources.

NOW, THEREFORE,


