A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR FELICIANO R. BELMONTE, JR., TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE ROMAN CATHOLIC ARCHBISHOP OF MANILA FOR THE RESTORATION, OPERATION AND USE OF THE QUEZON CITY GENERAL HOSPITAL (QCGH) CHAPEL LOCATED AT SEMINARY ROAD, EDSA, QUEZON CITY.

WHEREAS, before its burning on June 8, 1992, the Quezon City General Hospital chapel served the spiritual needs of the patients and the employees, and as a community chapel for those of the surrounding communities;

WHEREAS, after its burning, the Sunday celebration of the Eucharist was held in makeshift chapel at the hospital main lobby;

WHEREAS, what used to be the QCGH Chapel is now used instead by the hospital's blue guards for their office and sleeping quarters and as venue for some of the activities of the hospital;

WHEREAS, various fund raising activities have been conducted by the QCGH employees for the restoration of the hospital since 1992;

WHEREAS, the final realization of this dream of rebuilding the chapel will accrue to the benefit of the patients and their relatives, the employees as well as the surrounding communities by serving their spiritual needs.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the Honorable City Mayor Feliciano R. Belmonte, Jr., in behalf of the Quezon City Government, to enter into a Memorandum of Agreement with the Roman Catholic Archbishop of Manila for the restoration, operation and use of the Quezon City General Hospital (QCGH) Chapel located at Seminary Road, EDSA, Quezon City.
