RESOLUTION NO. SP **1838** S-2002

A RESOLUTION EXTENDING FINANCIAL ASSISTANCE TO SPO3 EMILIANO S. BUENO, JR., MEMBER OF THE CENTRAL POLICE DISTRICT COMMAND (CPDC), PHILIPPINE NATIONAL POLICE (PNP) WHO WAS COMPULSORILY RETIRED ON JUNE 6, 2001, IN THE AMOUNT OF THIRTY THOUSAND PESOS (P30,000.00), THE AMOUNT TO BE CHARGED AGAINST THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS IN THE 2002 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS THEREFOR.



Bueno, Jr., deserves to be extended financial assistance to lighten the burden of his family as a result of his total permanent disability and compulsory retirement from the service.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to extend, as it does hereby extend, financial assistance to SPO3 Emiliano S. Bueno, Jr., member of the Central Police District Command (CPDC), Philippine National Police (PNP) who was compulsorily retired on June 6, 2001, in the amount of Thirty Thousand Pesos (P30,000.00), the amount to be charged against the appropriation for Grants, Subsidies and Contributions in the 2002 Annual Budget of the Office of the City Mayor or from any available funds therefor.


