RESOLUTION NO. SP-1839 2002

A RESOLUTION REQUESTING THE HONORABLE CITY MAYOR TO GRANT FINANCIAL ASSISTANCE IN THE AMOUNT OF THIRTY THOUSAND PESOS (P30,000.00) TO BARANGAY KAGAWAD ANGEL GONZALES OF BARANGAY U.P. CAMPUS, DISTRICT IV, QUEZON CITY, WHO DIED OF HEART SEIZURE AS A RESULT OF COMPLICATED ILLNESS ON MARCH 7, 1999, TO BE CHARGED AGAINST THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS UNDER THE 2002 ANNUAL BUDGET OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS IN THE CITY TREASURY.

WHEREAS, Barangay Kagawad Angel Gonzales had been one of staunchest leaders of Barangay UP Campus whose dedicated service to his community deserves merit and recognition;

WHEREAS, Barangay Kagawad Angel Gonzales underwent a surgical operation and was hospitalized for more than a month for the amputation of both feet and on March 7, 1999 died due to heart seizure;

WHEREAS, there is nothing more appropriate under this circumstance than to grant him financial assistance to defray expenses he and his family had actually incurred during his hospitalization.


NOW, THEREFORE,




