RESOLUTION NO. SP- 1842, S-2002

A RESOLUTION EXTENDING FINANCIAL ASSISTANCE TO SPO4 SERAFIN C. VERA, MEMBER OF THE CENTRAL POLICE DISTRICT COMMAND (CPDC), PHILIPPINE NATIONAL POLICE (PNP) WHO WAS COMPULSORILY RETIRED ON MAY 17, 2001, IN THE AMOUNT OF THIRTY THOUSAND PESOS (P30,000.00), THE AMOUNT TO BE CHARGED AGAINST THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS IN THE 2002 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS THEREFOR.


