RESOLUTION NO. SP-**1843**S-2002

A RESOLUTION AUTHORIZING THE SANGGUNIANG BARANGAY OF UNANG SIGAW, THIS CITY, TO USE THEIR CALAMITY FUND BUDGET AMOUNTING TO ONE HUNDRED TWENTY-NINE THOUSAND PESOS (P129,000.00) FOR THE PAYMENT OF THE RELIEF GOODS AND OTHER OBLIGATIONS THEY HAVE INCURRED DURING AND AFTER THE CONFLAGRATION THAT TOOK PLACE IN THEIR BARANGAY LAST FEBRUARY 23, 2002.

WHEREAS, the fire that occurred last February 23, 2002 at Gana Compound, Barangay Unang Sigaw, 2nd District, this City, has destroyed, more or less, two hundred (200) houses and rendered, more or less, six hundred (600) families homeless;

WHEREAS, Ordinance No. SP-1117, Series of 2002 has declared the conflagration that took place in Barangay Unang Sigaw, particularly the Gana Compound, as a calamity;

WHEREAS, it is the foremost duty of the Barangay officials to promote and to look after the welfare of their constituents;

WHEREAS, the Sangguniang Barangay of Unang Sigaw has authorized their Barangay Chairman to disburse the Calamity and Discretionary Funds to enable them to immediately procure relief goods and other necessities for the fire victims to prevent danger and further loss of lives;

WHEREAS, these Calamity and Discretionary Funds were appropriated under Ordinance No. 01 Series of 2002, the Regular Budget of Barangay Unang Sigaw and within the guidelines set forth in the Local Government Code of 1991.


WHEREAS, proper documentation of the different purchases has already been prepared by the Barangay Council and the supplier is already available for submission and inspection.


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the Sangguniang Barangay of Unang Sigaw, this City, to use the amount of One Hundred Twenty-Nine Thousand Pesos (P129,000.00) from their 2002 Calamity Fund Budget for the payment of the relief goods and other obligations they have incurred during and after the conflagration that took place in their barangay last February 23, 2002.


