RESOLUTION NO. SP-**1846**, S-2002

A RESOLUTION AUTHORIZING THE HON. FELICIANO B. BELMONTE, JR., CITY MAYOR, TO ACQUIRE A PIECE OF REAL PROPERTY IN BARANGAY PAYATAS FOR A MATERIALS RECOVERY AND VOLUME REDUCTION FACILITY.

WHEREAS, the Honorable City Mayor, Feliciano R. Belmonte, Jr. has formally requested this Council for authority to purchase a piece of property in Barangay Payatas, this City, for a Materials Recovery and Volume Reduction Facility (MRVRF) for the proper disposal and management of the City's solid waste;

WHEREAS, the property, consisting of twelve thousand one hundred and seven square meters (12,107 m²) is located in La Unica Hija Subdivision;

WHEREAS, the GSI Board of Trustees has, in response to the Honorable Mayor's communication of his Office's interest in the said property, issued Resolution No. 119 dated 7 May, 2002, approving the sale of said property to the Quezon City Government for the specific purpose of constructing the MRVRF;

WHEREAS, the Honorable City Mayor anchors the purchase of said property on the provisions of Republic Act No. 9003 or the Ecological Solid Waste Management Act of 2000;

WHEREAS, under Section 458(a)(5)(xiii) of the Local Government Code of 1991, the Council is authorized, *inter alia*, to provide for an efficient and affective system of solid waste and garbage collection and disposal;


WHEREAS, considering the ever-increasing volume of solid waste that this City produces on a daily basis, it cannot be argued that the proposed purchase will prove beneficial to this City and its residents;

WHEREAS, the Honorable Mayor must be given the authority to acquire for the City Government this piece of property located in Barangay Payatas and subject of Resolution No. 119, s. 2002 of the GSIS Board of Trustees for the purpose of constructing thereon the City's MRVRF.


NOW, THEREFORE,
