RESOLUTION NO. SP **1847**, S-2002

A RESOLUTION AUTHORIZING THE HONORABLE FELICIANO R. BELMONTE, JR., CITY MAYOR, THIS CITY TO NEGOTIATE WITH ISUZU PHILIPPINES CORPORATION FOR THE PURCHASE OF A FLEET OF MOTOR VEHICLES, PARTICULARLY ISUZU HILANDER CROSSWIND XUV AUTOMATIC, FOR THE USE OF THE DIFFERENT CITY GOVERNMENT OFFICIALS.

Introduced by Councilors JESUS "BONG" C. SUNTAY, WILMA AMORANTO-SARINO, VINCENT P. CRISOLOGO, VICTOR V. FERRER, JR., BERNADETTE HERRERA-DY, JULIAN M.L. COSETENG, WENCEROM BENEDICT C. LAGUMBAY, JANET M. MALAYA and ALMARIO E. FRANCISCO.

WHEREAS, every local government unit is mandated by the Local Government Code of 1991, under Section 17 thereof, to ensure the efficient and effective provision of the basic services and facilities enumerated thereunder;

WHEREAS, compliance with this legal mandate would be facilitated by providing the different Quezon City Government Officials with a motor vehicle for use by their respective offices in their official mission and services;

WHEREAS, the Honorable City Mayor should be authorized to enter into a contract with a reputable motor vehicle distributor for the purchase of a fleet of motor vehicles, particularly for the use of the Quezon City government officials.

NOW, THEREFORE,


BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the Honorable Feliciano R. Belmonte, Jr., City Mayor, this city, to negotiate with Isuzu Philippines Corporation for the purchase of a fleet of motor vehicles, particularly Isuzu Hilander Crosswind XUV automatic, for the the use of the different city government officials.

RESOLVED, FURTHER, that a training seminar for the Q.C. motorpool drivers and mechanics be included in the purchase agreement relative to the maintenance of the subject vehicles.

RESOLVED, FURTHERMORE, that all pertinent documents relative thereto shall form integral parts of this resolution.


