RESOLUTION NO. SP- 1848, 2002

A RESOLUTION STRONGLY URGING QUEZON CITY MAYOR, FELICIANO R. BELMONTE, JR., TO GRANT INCENTIVE ALLOWANCE OF P2,000.00 PER MONTH TO ALL QUEZON CITY BARANGAY NUTRITION SCHOLARS CHARGED AGAINST THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS OR ANY OTHER AVAILABLE AND ALLOWABLE FUNDS FOR THE PURPOSE IN THE CITY TREASURY.


WHEREAS, they are also adversely affected by the economic difficulties in our midst, and fairly deserve to be granted additional allowances to keep them going and maintain their services.


