A RESOLUTION FORMALLY ADOPTING OPEN OR THE ONLINE PROCEDURES ENHANCEMENT FOR CIVIL APPLICATIONS INITIATED BY THE CITY OF SEOUL, KOREA, TO PROMOTE TRANSPARENCY AND TO IMPROVE AND ENHANCE THE ADMINISTRATIVE FUNCTIONS OF THE CITY.

WHEREAS, OPEN or the Online Procedures Enhancement for Civil Applications is the successful corruption-prevention system evolved by the City of Seoul, Korea, on the INTERNET;

WHEREAS, OPEN, as a comprehensive and systematic Anti-Corruption System ensures the transparency of public administration in local governments and is a powerful tool to improve and enhance the administration.

WHEREAS, thru OPEN, the Seoul Metropolitan Government has received cheers and accolades of international organizations for shedding off much of its old stigma as a "pandemonium or hotbed of corrupt officials" in a matter of just a few years;

WHEREAS, the Quezon City Government can do no less than to adopt OPEN as a corruption prevention program if it is to become a model of transparency among local governments in the country;

WHEREAS, the Transparency International of the United Nations has praised OPEN as a model program against corruption and endorsed its adoption by other cities in the world.
