RESOLUTION NO. SP. 1855, S-2002

A RESOLUTION URGING THE HONORABLE CITY MAYOR, FELICIANO R. BELMONTE JR., TO GRANT FINANCIAL ASSISTANCE IN THE AMOUNT OF THIRTY THOUSAND PESOS (P30,000.00) TO THE FAMILY OF THE LATE SPO4 MANUEL R. HERMOSURA, A FORMER MEMBER OF THE CENTRAL POLICE DISTRICT COMMAND, (CPDC), PHILIPPINE NATIONAL POLICE (PNP), THE AMOUNT TO BE CHARGED AGAINST THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS IN THE 2002 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR.

WHEREAS, in recognition of his more than 10 years of continuous devoted service in the maintenance of peace and order particularly in Quezon City, the late SPO4 Manuel R. Hermosura deserves to be extended financial assistance to lighten the burden of his bereaved family occasioned by his untimely death.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to urge, as it does hereby urge, the Honorable City Mayor, Feliciano R. Belmonte, Jr., to grant financial assistance in the amount of Thirty Thousand Pesos (P30,000.00) to the family of the late SPO4 Manuel R. Hermosura, a former member of the Central Police District Command (CPDC), Philippine National Police (PNP), the amount to be charged against the appropriation for Grants, Subsidies and Contributions in the 2002 Annual Budget of the Office of the City Mayor.
