RESOLUTION NO. SP-**1856**, S-2002

A RESOLUTION AUTHORIZING THE HONORABLE VICE MAYOR HERBERT M. BAUTISTA TO ENTER INTO NEGOTIATED CONTRACTS FOR ANY AND ALL COMMUNITY BASED PROJECTS AND EXPENSES FOR TRAININGS AND SEMINARS AMOUNTING TO NOT MORE THAN ONE MILLION PESOS (PHP 1,000,000.00) PER CONTRACT, THE AMOUNT NECESSARY THEREFOR TO BE TAKEN FROM THE ANNUAL BUDGET OF THE OFFICE OF THE VICE MAYOR.

WHEREAS, the projects will redound to the benefit of the residents living thereat and will be enjoyed by the constituents and the general public;




