WHEREAS, Smart Telecommunications, Inc., has complied with the requirements for the issuance of a Special Use Permit as required by said Ordinance;

WHEREAS, the construction and operation of the cell site will promote public convenience and economic development, through the improvement of telecommunication facilities in the city.






