BELMONTE, JR., TO PURCHASE THAT CERTAIN PARCEL OF LAND WITH AN AREA OF ONE THOUSAND NINE HUNDRED EIGHTY- THREE SQUARE METERS (1,983 SQ.M.) REGISTERED IN THE NAME OF FLORENTINO S. CATAHAN DESCRIBED UNDER TRANSFER CERTIFICATE OF TITLE NUMBERED 64098 OF THE REGISTRY OF DEEDS OF QUEZON CITY TO BE USED AS THE SITE FOR THE CONSTRUCTION OF THE PROPOSED OLD BALARA ELEMENTARY SCHOOL (ANNEX).

WHEREAS, the Old Balara Elementary School has only 18 classrooms for a student population of 3,770 during the past school year and is presently in dire need of additional twenty-seven (27) classrooms to accommodate the increasing number of school children for the current school year;

WHEREAS, the former Punong Barangay Manuel Mira of Barangay Balara has proposed to purchase the property owned by Mr. Florentino S. Catahan upon the request of the Barangay Council and the Parents Teachers Association at the price of P5,987.00 per square meter from P8,000.00 originally offered by Mr. Catahan as the site of the proposed Old Balara Elementary School (Annex), specifically identified as follows:

Belmonte, Jr., to purchase that certain parcel of land with an area of One Thousand Nine Hundred Eighty Three square meters (1,983 sqm.) registered in the name of Florentino S. Catahan described under Transfer Certificate of Numbered 64098 of the Registry of Deeds of Quezon City, to be used as the site for the construction of the proposed Old Balara Elementary School (Annex).
