RESOLUTION NO. SP-**1868**, S-2002

A RESOLUTION AUTHORIZING THE CITY MAYOR HONORABLE FELICIANO R. BELMONTE, JR., TO INCREASE THE SALARY OF OUR CITY TREASURER, DR. VICTOR B. ENDRIGA, FROM HIS CURRENT SALARY OF TWO HUNDRED SIXTY-SEVEN THOUSAND SIX HUNDRED EIGHTY-FOUR PESOS (P267,684.00) TO TWO HUNDRED NINETY-FIVE THOUSAND THREE HUNDRED EIGHT PESOS (P295,308.00) ANNUALLY, PURSUANT TO CIVIL SERVICE COMMISSION RESOLUTION NO. 011429.

WHEREAS, the office of the City Mayor and the City Council are very much aware that the City Treasurer of Quezon City has a salary grade 27 as indicated in his appointment paper;

WHEREAS, the City Treasurer now receives a salary of Two Hundred Sixty-Seven Thousand Six Hundred Eighty-Four (P267,684.00) Pesos which corresponds to Salary Grade 27;


WHEREAS, the Pasig City Treasurer, a co-equal officer receives Two Hundred Ninety-Five Thousand Three Hundred Eight Pesos (P295,308.00) annual salary;

WHEREAS, the Quezon City Government is in a financial position to grant the City Treasurer of Quezon City the amount of Two Hundred Ninety-Five Thousand Three Hundred Eight Pesos (P295,308.00) as annual compensation.

NOW, THEREFORE




