RESOLUTION NO. SP 1871, S-2002

A RESOLUTION REQUESTING THE CITY MAYOR, HONORABLE FELICIANO R. BELMONTE, JR., TO ALLOCATE THE AMOUNT OF FIVE HUNDRED EIGHTY-SEVEN THOUSAND SEVEN HUNDRED SEVENTY-SIX PESOS (P587,776.00) TO COVER THE COST OF INSTALLATION OF STREETLIGHTS FROM PALAWAN STREET TO SAMAR STREET, BARANGAY STO. CRISTO, QUEZON CITY, THE SAID AMOUNT TO BE TAKEN FROM ANY AVAILABLE FUND IN THE CITY TREASURY.



cover the cost of installation of streetlights from Palawan Street to Samar Street, Barangay Sto. Cristo, Quezon City, the said amount to be taken from any available fund in the City Treasury.
