BAUTISTA, CITY VICE MAYOR, THIS CITY, TO ENTER INTO A NEGOTIATED CONTRACT WITH THE CENTRAL PERIPHERALS CORPORATION, REPRESENTED BY MR. JOSEPH YEO, PRESIDENT, FOR THE IMPROVEMENT / UPGRADING OF THE LOCAL NETWORK SYSTEM AND COMPUTERIZATION OF THE OPERATION OF THE QUEZON CITY COUNCIL.

WHEREAS, in response to the need for full computerization of the legislative system, the City Council intends to improve its operation and functionality by installing upgraded network system and by improving existing computer units;

WHEREAS, the Central Peripherals Corporation, a private entity duly organized and registered under Philippine laws, engaged in selling computer products and a leading service provider, after a series of consultations has proven capacity to undertake the said computerization and modernization.
