A RESOLUTION STRONGLY URGING THE GOVERNMENT SERVICE INSURANCE SYSTEM (GSIS) AND THE SOCIAL SECURITY SYSTEM (SSS) TO ESTABLISH THEIR RESPECTIVE COLLEGE EDUCATIONAL TRUST FUND FOR GRANTEES OF THEIR MEMBERS TO GIVE THEM THE OPPORTUNITY FOR HIGHER AND QUALITY EDUCATION.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to urge, as it does hereby strongly urge, the Government Service Insurance System (GSIS) and the Social Security System (SSS) to establish their respective College Educational Trust Fund for grantees of their members to give them the opportunity for higher and quality education.
