RESOLUTION NO. SP-**1878**S-2001

A RESOLUTION SUPPORTING HOUSE BILL NO. 2605 ENTITLED "AN ACT PROVIDING FOR A ONE HUNDRED TWENTY FIVE PESOS (P125.00) DAILY ACROSS-THE-BOARD INCREASE IN THE WAGE AND SALARY RATE OF EMPLOYEES AND WORKERS IN THE PRIVATE SECTOR, AND FOR OTHER PURPOSES."

WHEREAS, in response to the growing clamor for wage and salary increase in the private sector, House Bill No. 2605 was filed in the House of Representatives by Bayan Muna House Representative, Honorable Satur Ocampo;

WHEREAS, it is common knowledge that the wages and salaries of workers and employees are unable to catch up with the rapid increase of the prices of prime commodities necessary to sustain a decent living;

WHEREAS, the economic difficulties which our country is suffering today has greatly affected the working man, that there appears to be a felt need for government intervention to save him from the economic quagmire into which he was thrown by forces beyond his control;

WHEREAS, the filing of House Bill No. 2605 in the House of Representatives is timely, and its approval and final enactment into law is awaited by millions of our laborers and employees in the private sector who feel that they are entitled to a fair share of the fruits of their labors.


NOW, THEREFORE,


