RESOLUTION NO. SP-**1879**-2002

A RESOLUTION ALLOCATING THE SUM OF FIVE HUNDRED TWENTY-FOUR THOUSAND PESOS (Php 524,000.00) FROM ANY AVAILABLE FUNDS FROM THE OFFICE OF THE CITY MAYOR TO FINANCE START-UP PROJECTS AND PROGRAMS OF THE GENDER DEVELOPMENT AND RESOURCE COORDINATING OFFICE (GAD-RCO).

WHEREAS, Republic Act 7192, otherwise known as the Women Development and Nation Building Act was approved on February 12, 1992 to recognize the role of Filipino women in nation building and to provide direction for mainstreaming gender concerns in development;

WHEREAS, Ordinance No. SP-1036, S-2001 created the City Gender and Development Council and the GAD-Resource and Coordinating Office (GAD-RCO) under the Office of the Mayor, defining its powers, duties, and functions and providing an annual budget and staff as mandated under Republic Act 7192;

WHEREAS, Executive Order No. 16, S-2002, issued by the Honorable Feliciano R. Belmonte, Jr. states that, "It is the express policy of the Quezon City Government to substantiate by way of programs and activities, the empowerment of women being co-equal in the development process.";


WHEREAS, to activate the GAD Council and to ensure the effective and efficient implementation of the critical activities of the same, for the remaining year 2002, there is a need for the approval of the Supplemental Budget of the GAD-RCO for the Year 2002.


