A RESOLUTION REQUESTING THE HONORABLE MAYOR FELICIANO R. BELMONTE, JR., TO ALLOCATE THE AMOUNT OF FORTY-ONE THOUSAND FIVE HUNDRED FORTY-ONE PESOS AND THIRTY-FIVE CENTAVOS (P41,541.35) FOR THE CONSTRUCTION OF A COVERED WALK ALONG TOLENTINO STREET AND LENCOLN STREET OF BARANGAY SAN ANTONIO, QUEZON CITY.

WHEREAS, the Barangay Council of Barangay San Antonio, Quezon City, under its duly approved resolution requested for the construction of a covered walk along Tolentino Street and Lincoln Street of said barangay;

WHEREAS, the City Engineer has estimated that the project will cost Forty-One Thousand Five Hundred Forty-One Pesos and Thirty-Five Centavos (P41,541.35), which amount is not available from any existing appropriation;
