RESOLUTION NO. SP 1885 S-2002

A RESOLUTION URGING THE CITY MAYOR, HONORABLE FELICIANO R. BELMONTE, JR., TO GIVE PRIORITY TO THE PAYMENT OF THE TERMINAL LEAVE OF FORMER CONTRACTUAL AND CASUAL EMPLOYEES WHO ARE ENTITLED TO LEAVE CREDITS.

WHEREAS, most of these employees were former contractual and casual employees with accrued leave credits, and who subsequently, filed claims for the payment of the value of money of their leave credits;

WHEREAS, most of the claimants are in dire need of financial support and the city government should now address this problem by giving to the former employees what rightfully belong them.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to urge, as it does hereby strongly urge, the City Mayor, Honorable Feliciano R. Belmonte, Jr., to give priority to the payment of the terminal leave of former contractual and casual employees who are entitled to the leave credits.
