A RESOLUTION AUTHORIZING THE HONORABLE FELICIANO R. BELMONTE, JR., QUEZON CITY MAYOR, TO DISBURSE AND RELEASE FUNDS FROM THE MAINTENANCE AND OTHER OPERATING EXPENSES (MOOE) OF ALL OFFICES FOR PAYMENT OF PAMASKONG HANDOG TO CONSULTANTS AND CONTRACTUALS.

WHEREAS, the Quezon City Government presently employs consultants and support service personnel whose services are covered by contracts;

WHEREAS, in keeping with the gift giving tradition every Yuletide season, there is a need to give these personnel Pamaskong Handog as a way of spreading Christmas cheers to them and their families;

WHEREAS, the City Mayor has certified as URGENT the enactment of this legislative measure;

WHEREAS, funds under MOOE of each office may be utilized for the payment thereof.

NOW THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor of Quezon City, Honorable Feliciano R. Belmonte, Jr., to disburse and release funds from the Maintenance and Other Operating Expenses (MOOE) of all Offices for payment of Pamaskong Handog to the city's consultants and contractual employees subject to pertinent laws, rules and regulations, according to the following schedule:

CONSULTANTS

Must have rendered four (4) months of continuous service for the period January 1 to October 31, 2002 and must still be in the service as of November 30, 2002.


For those who have rendered less than four (4) months of service and are still employed as of November 30, 2002, the following schedule shall govern:

1 month but less than 2 months	25%
