RESOLUTION NO. SP-**1891** S-2002

A RESOLUTION URGING THE CITY MAYOR, HONORABLE FELICIANO R. BELMONTE, JR., TO EXTEND FINANCIAL ASSISTANCE TO SPO1 EFREN L. VEGO, MEMBER OF THE CENTRAL POLICE DISTRICT OFFICE (CPDO) PHILIPPINE NATIONAL POLICE (PNP), WHO WAS COMPULSORILY RETIRED ON AUGUST 9, 2001, IN THE AMOUNT OF THIRTY THOUSAND PESOS (P30,000.00) THE AMOUNT TO BE CHARGED AGAINST THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS IN THE 2002 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS THEREFOR.

WHEREAS, in recognition of his long and continuous public service particularly in the maintenance of peace and order in Quezon City, SPO1 Efren L. Vego deserves to be extended financial assistance to lighten the burden of his family as a result of his total permanent disability and compulsory retirement from the service.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to urge, as it does hereby urge, the City Mayor, Honorable Feliciano R. Belmonte, Jr., to extend financial assistance to SPO1 Efren L. Vego, member of the Central Police District Office (CPDO), Philippine National Police (PNP), who was compulsorily retired on August 9, 2001, in the amount of


