RESOLUTION NO. SP **1892** S-2002

A RESOLUTION AUTHORIZING THE HONORABLE FELICIANO R. BELMONTE, JR., CITY MAYOR, TO ENTER INTO AN AGREEMENT WITH A SURVEYING COMPANY FOR THE PREPARATION OF A SUBDIVISION PLAN, TECHNICAL DESCRIPTION OF LOTS AND OTHER INDIVIDUAL TITLING DOCUMENTATION NEEDS FOR A CITY-OWNED PROPERTY IN BARANGAY ESCOPA III.

WHEREAS, City Resolution No. SP-393, S-94 authorized the distribution to qualified beneficiaries through direct sale of lots in a City-owned property consisting of, more or less, a total of 44,486 square meters in Barangay Escopa III, under the Escopa Urban Redevelopment Program;

WHEREAS, there is a need to prepare the subdivision plan and the individual technical description of the lots as a requirement for their individual titling and registration;

WHEREAS, the Quezon City Government will advance the amount representing professional fees for the preparation and approval of the subdivision plan and technical description of lots, and the release of individual titles;


WHEREAS, the beneficiaries/awardees will pay directly to the Quezon City Government the amount advanced/subsidized in six (6) monthly installments without interests.
