A RESOLUTION AUTHORIZING THE HONORABLE MAYOR FELICIANO BELMONTE, JR., CITY MAYOR, TO DISBURSE AND RELEASE FUNDS FROM THE MAINTENANCE AND OTHER OPERATING EXPENSES (MOOE) FOR PAYMENT OF ADDITIONAL ONE THOUSAND PESOS (P1,000.00) PAMASKONG HANDOG TO CONSULTANTS AND CONTRACTUAL PERSONNEL.
