RESOLUTION NO. SP-**1894**, S-2002

A RESOLUTION AUTHORIZING THE HONORABLE FELICIANO R. BELMONTE, JR., CITY MAYOR, THIS CITY, TO DISBURSE AND RELEASE FUNDS FROM THE MAINTENANCE AND OTHER OPERATING EXPENSES (MOOE) FOR PAYMENT OF ADDITIONAL THREE THOUSAND PESOS (P3,000.00) CASH GIFT TO ALL ITS PERMANENT AND CO-TERMINUS PERSONNEL.

NOW, THEREFORE,




