A RESOLUTION AUTHORIZING THE CITY MAYOR OF QUEZON CITY, HONORABLE FELICIANO R. BELMONTE, JR., TO ENTER INTO A CONTRACT WITH OTIS ELEVATOR COMPANY (PHILIPPINES), INC., FOR THE REHABILITATION OF THE ELEVATOR SERVICE AT THE LOBBY OF THE LEGISLATIVE WING OF THE QUEZON CITY HALL.


NOW, THEREFORE
