WHEREAS, its realization will benefit the Quezon City Taxpayers and will definitely redound to the best interests of the city.


NOW, THEREFORE,

ing.


RESOLVED, FURTHER, that the assessment area (business and realty tax) shall be located at the ground floor with additional counters provided.
